## Mobile Banking Security Tip:

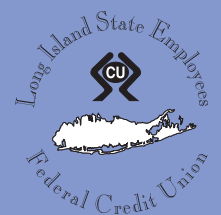
### Mobile Text Phishing Scam

We have recently been made aware of a Mobile text scam that some credit unions are experiencing.



This fraudulent attempt to capture account information is done with an automated SMS/text Message. The text message requests members to enter their account information (including ATM PIN number). Members should avoid clicking links within the text messages and not respond to these messages that request account information.

Limit the release of your personal information to protect yourself from fraud.
